

NCSA-PEP TRAFFIC INSTRUCTIONS - RADIO September 1-30, 2023

Thank you for your support of the OAB's NCSA-PEP program! Below is information about our TWO radio campaigns airing during the month of September.

The **Ohio Army National Guard (OHNG)** is a new campaign beginning on September 1. The campaign will air for one year through Aug. 31, 2024. The **Ohio Secretary of State (OSOS)** is also starting a new campaign on Sept. 1 to promote the November General Election. The spot will continue through Nov. 7 (Election Day), at which time it should be removed from rotation.

Please note that the **Ohio Association of Foodbanks (OAOF)** campaign ended on Aug. 15 and should no longer be in rotation. The **Angels on Track Foundation (OAOT) and Ohio Dept. of Education (ODOE)** campaigns both end on Aug. 31 and should be removed at that time.

All OAB NCSA-PEP spots are approved for web streaming and may be posted on station websites.
